

Media Consent and Release Form

Tandem Diabetes Care, Inc. is thrilled that you are willing to participate in Team Tandem and to share your/your child's experiences with our products and diabetes. Sharing your/your child's story can help others who are interested in learning about options for managing their diabetes.

We respect your/your child's privacy. To ensure that we are acting in accordance with your wishes, and using your/your child's information with your permission, we ask you to sign this Media Consent and Release Form ("Release"). We will keep a copy of your written permission on file.

Please read this entire form carefully and in its entirety. Electronically signing this Media Consent and Release Form gives us permission to use you/your child's images and diabetes story as set forth below.

I hereby consent and grant to Tandem Diabetes Care, Inc. and/or its subsidiaries, affiliates, and representatives (collectively, "Tandem"), the right to use and/or disclose my/my child's identifiable personal and/or medical information relating to diabetes publicly (collectively, "Information") on various channels, including in print (newspapers, magazines, marketing materials, among other forms of print) and online via Tandem's website, social media channels (Facebook, Instagram, Twitter, YouTube, etc.), email, television, and radio, for the following purposes:

- Marketing and promotion of the services and products of Tandem both online and in print
- Educational and informational presentations (including any online educational courses or training videos)
- Scientific, academic, or medical conference presentations or publications

Tandem may use my/my child's Information in photographs, videos, video clips or images, audio recordings of my/my child's voice, pictures, images, drawings, or other renderings, quotes and/or statements made by me/my child in both electronic and non-electronic media (collectively, "Content").

I grant Tandem the perpetual, worldwide, sublicensable, assignable and royalty-free right and license to use, reuse, copy, modify, edit, alter, create derivative works, publish, display, distribute, perform, and transmit Content ("Publicity Rights") in any and all media and formats now existing or subsequently developed, in their sole discretion, for the purposes

described herein. This right and license extends to all languages, media, formats, and markets now known or hereafter created.

I am participating as a volunteer and am not required to participate in Team Tandem or grant the rights granted in this Release as a condition of my/my child's continued treatment. I represent that I have the right to allow Tandem to use the Content described above. I waive any and all privacy, publicity, moral rights, or any other rights of a similar nature I have or may have (if any) in connection with the Content or any portion thereof, and I assign to Tandem any and all right, title, or interest I may have in the Content itself, if any.

I understand that I will not receive, and hereby waive any rights to receive any royalty or other monetary compensation, now or in the future, for this grant to Tandem of my/my child's Publicity Rights. I further understand that signing this Release or providing Information to Tandem does not guarantee that Tandem will publish or post any Content depicting my/my child's Information. I hereby waive any right that I may have to inspect or approve any uses made of my/my child's Publicity Rights in connection with this Release.

I hereby release and discharge the Released Parties from any and all liability arising out of or in any way connected to their exercise of the Publicity Rights for the authorized purposes described above, including without limitation, any liability based on rights of publicity, invasion of privacy and other civil rights, moral rights, copyright infringement, defamations, libel and slander, or as a result of any distortion, blurring, or alteration, optical illusion, or use of the Content in composite form.

This Release shall not expire and there is no geographic limitation on where these Publicity Rights may be exercised. I understand that I may revoke this Release by sending a written request to Tandem Diabetes Care, ATTN: Legal Department, 11075 Roselle Street, San Diego, CA 92121. I also understand that such revocation will not be effective with respect to Content that has already been used and/or disclosed per this Release.

I agree that this release will be construed and interpreted in accordance with the internal laws of the State of California without regard to conflicts of laws principles. I certify that I am over the age of eighteen (18) years and have legal capacity to sign this Release.
